# PROBLEM & OBJECTIVE

**PROBLEM** Although not cancer specific the Hospice and Palliative Care Act is key to the provision of end of life care to cancer patients.

**OBJECTIVE** Equitable access to hospice and palliative care services for all settings (at home, nursing/care homes, hospitals and hospices).

#### **KEY COMPONENTS / STEPS**

- November 2015: The Hospice Palliative Care Act was passed by the German Parliament and came into force in December 2015.
- The main objectives of the act were:
- Improving access to hospice and palliative care services for all settings in Germany.
- Strengthening cooperation between professional and voluntary services, medical, nursing, hospice and psychosocial support in networks.
- Provision of customized advice and support to patients/families about the availability of services.
- Implementation at the federal level and Laender/regional level by way of secondary legislation (guidelines, regulations, contractual agreement, legal acts).

#### **KEY CONTEXTUAL FACTORS**

• The German statutory health insurance covers completely the necessary medical care for terminally ill patients.

#### MAIN IMPACTS / ADDED VALUE

The "2015 Hospice Palliative Care Act" has significantly:

- Further developed hospice and palliative care in Germany ensuring equitable access to multi-disciplinary and crosssectoral services for all settings (at home, nursing/care homes, hospitals and hospices).
- Provided legal clarification that palliative care is an integral part of medical care provided by the German Statutory Health Insurance.
- Introduced additional ambulatory medical services for the delivery of especially qualified and coordinated medical care.
- Improved funding of hospices for children and adults (in-patient care) as well as ambulatory hospice care.
- Strengthened palliative care and the awareness for the need of hospice care in in-patient nursing homes as well as hospitals.

#### **LESSONS LEARNED**

In a federal system formal approaches (e.g. legislation) are effective to implement programmatic public health policy.
Involvement of all stakeholders and levels of decision making is paramount.
